3. Precision company is a full year commitment, and there will be extra rehearsals on occasion, as well as occasional community performances. Intensity Company commitment begins in August with Intensive and ends at the end of May. Dancers are strongly encouraged to take some technique classes in the summer to avoid losing technique, strength, and flexibility. Also, each child is expected to practice and have good attendance each week, with the exception of sickness. Excessive or important missed rehearsals could possibly result in a private lesson at an additional expense. \_\_\_\_\_

4. All fees are due on time, and if delinquent, without direct communication with the director, they will be charged to your credit card if you are late in payment. **A credit card must be kept on file** for all company members. If your credit card declines, and there is still no communication with the director, you will be released from the company, and will still be liable for all monies owed, including the re-choreography / contract breaking fee. \_\_\_\_\_

5. Company photos will be taken by a professional photographer the week after intensives. Approximate cost is \$150.00 per student. These photos will be used for personal use, advertisements, social media, etc. There is an additional cost for the company outfit for the photo shoot. \_\_\_\_\_

6. Parents are expected to be helpful and exemplary members of the studio, to support and be kind to each other, respect all instructors, the owner, and all of the children that go to the studio.
